3	N/A	Have there been roof leaks or water intrusion issues into the areas in the scope of the project?	The facility has not encountered roof leaks at the location.
4	N/A	Are existing drawings available besides what was provided in the RFQ?	The WVH facility manager has paper drawings of various buildings at the site, however, they are archived together and it would take some effort and time to find specific drawings. Most and possibly all are not electronically scanned at this time. Respondents to the RFQ may want to assume that as-built drawings may have to be created from actual observations at the site.
5	N/A	Are there asbestos containing materials?	The facility was surveyed and reports prepared that establish that there are no asbestos containing materials that would affect the project scope.
6	N/A	General Comments	The facility is a mixed use facility, and serves both men and women in the transitional housing program. Some functions are separated into areas appropriate for each. Level 1 and Level 2 was described in the RFQ graphic as being within the scope, however, the basement area under Level 1 is also within the scope, as plumbing extends into the basement level.
