Purpose: The purpose of this rule change is to remove the annual print management strategy reporting requirement on state agencies, boards and commissions, and higher education institutions. Statutory print management rulemaking requirements on DES do not address reporting. Removing the reporting requirement reduces redundancy and frees up state resources better committed to the Legislature's goals to increase efficiencies and reduce costs.
