## CAPITAL PROJECTS ADVISOR REVIEW BOARD PROJECT REVIEW COMMITTEE (PRC) RECRUITMENT PLAN

The <u>Project Review Committee</u> (PRC) was created by the Washington State Legislature and is responsible for reviewing and approving public body certifications and project approval applications for the utilization of General Contractor/Construction Manager (GC/CM) and Design-Build (DB) delivery methods of public works construction. The PRC is comprised of members from different public and private entities with wide variety of backgrounds, experience, and expertise in the construction industry.

Applications to serve on the PRC need to be reviewed and voted upon by the Capital Projects Advisory Review Board (CPARB). CPARB meets 6 times a year to review alternative public works contracting procedures and provides guidance to state policymakers on ways to further enhance the quality, efficiency and accountability of public works contracting methods. PRC letters of interest need to be collected and reviewed with ample time for the Board to discuss and appoint new members to avoid gaps in PRC membership.

PRC members serve three-year terms, beginning in July of the year they are appointed. Review of the upcoming member expiration dates need to be made in the fall to give plenty of time to post recruitment and incorporate application review into the spring CPARB meetings.
