- Almira School Fire Replacement Project

Presentation:

- Project Cost: approximately \$21M; pending insurance reimbursement negotiations and legislative delegation of funds for Emergency Declaration.
- Replace combined Elementary and Middle School building lost by fire on October 13, 2021. New facility will replace original 44,000 sf building.
- Project meets RCW Requirements for Design-Build.
- Team has adequate experience and capacity for project success

Public Comment:

Janice Zahn with Port of Seattle and CPARB Chair: She wanted to comment that she can appreciate how difficult this must be to have a school burned down and have an emergency. With that said, she wanted to raise the concern about the fact that there was no state of emergency declared by the school district, and so she would also comment that if that would have happened then the RCW 39.04.280(1e) waving the competitive bidding and the factual basis, after the fact of explaining the exception, and having that recorded, which is (2a) would have been triggered. Instead, what we have is relying on the fact that 39.10.280 is interpreted to mean that you could actually get all the way to selecting a design-build firm and only awarding and signing the contract. RCW 39.10.280 says must apply for approval from the committee to use the design-build or GC/CM contracting procedure on a project. She thinks this is really concerning that we are going this far, without declaring an emergency and putting, CPARB and the PRC in a pretty untenable position. For the record, she's also concerned about the fact that we had the CPARB vice chair and the PRC chair that was notified about this. She was not notified about it and there wasn't a special meeting to look at this. This is something that we're going to need to talk about on CPARB when the PRC reports out on this, whichever way the panel decides to go, this is not the direction she believes that the PRC should be taking, and how we interpret the RCW. And this is a comment more for the consultants that are supporting the school district and not necessarily the school district itself. She can appreciate how difficult it must be to be in this position. She believes we could have done better, and she wanted to make sure that the panel got those comments from her.

Jesse Brunner is the Almira School Board Chair: His children are the fourth generation of his family to attend the school, which is something that is certainly not unique to them. When they lost the school, it was tragic hit to our

Community. The school is not just the building where their children are educated, it's the building that really is the heart of the Community. It is their Community Center. This is the building where all the children's sports are played. It's the building where they have weddings, funerals, gatherings of all type and fundraisers. When they lost the school, they lost the meeting place that keeps their Community together and allows them to interact. He appreciates the opportunity to share his thoughts on how important this building is to them, and how important it is that they get a new building put in place to replace it. Hopefully it'll be there for the next 75 years. He's looking forward to having his kids be able to go to a regular classroom and get the education that they're used to receiving.

Ken Murphy with ALSC: Being part of this towards the very end, where we're at right now is our observation has been that to meet the needs of this Community. No steps have been skipped at this point, but they have and what the district has done is layer one process on top of others where usually they're strung out next to each other in order to meet this crisis and to meet the needs of the Community. Maybe they could have taken a different approach as has been discussed, as far as having an emergency meeting, but this is still the right process from what we've seen to address the needs of this community and quickest and most flexible way possible.

Cameron Castensen with Almira School Board: Almira board director and he wanted to reiterate what Jesse said. This is a tragic situation. We volunteer as board members of our Community. He believes that an emergency was declared in this situation. He has three children going to school. Right now, they're going to two different buildings and a third for PE. They appreciate the PRC's consideration and getting this approved asap so they can move on and try to get a school by fall of 2023.

Jamie with the Walsh-Garco: He echoes what Ken Murphy had to say. From their perspective, the process of statement of qualifications, interview fee proposals you know all the typical guidelines and processes are getting layered to try to reduce the timeline from Garko Analys' perspective. They're certainly, ready to help expedite the construction of the new school for Almira as quickly as they can.

Deliberation:

Aside from sequencing, Almira is following Progressive Design-Build. This process gives them some flexibility, but the Emergency Declaration process isn't necessarily any faster than acquiring PRC approval. There was some concern with the definition of the scope, but Progressive Design-Build is the right method for this project to be successful.

Conclusion:

David Johnson made the motion to approve this project application and Taine Wilton seconded the motion. **Approved 6/8** 2 panelists were concerned with vagueness of funding costs leading to ambiguous scope. There were additional concerns that the procurement process was completed prior to PRC approval though signed contracts were pending this approval.
