 - iii. Reports to include recommendations regarding reconciliation of billed amounts and recorded costs. The Consultant may be asked to provide additional related duties, not specifically identified above on an as-need basis when requested.

3.0 Other Information

Consultants selected have no implied guarantee of a minimum number of Projects or amount of fees to be earned during the 23-25 biennium. 5.0 Next Steps

Following the evaluation of submittals (Phase1), a consultant selection board will review submittals provided by each consultant for each disciple, and invite the most-qualified consultants to participate in interviews (Phase 2). Interviews will be held virtually.

The Phase 2 interview criteria and total possible points are specific to the services listed for each discipline and include consultant staff introductions who will actually perform on-call services along with consultant's capabilities and organizational structure for providing the desired services.

The top scoring consultants from Phase 2 will be deemed to be "most highly qualified" to perform the desired services within each discipline and will be added to the "On-Call Roster" for each discipline. These consultants may be called upon at any time during the biennium to scope and perform the desired services.

Consultants responding to this solicitation will be notified in writing of the selection results on or before May 26, 2023.

Final selections will be based on the merits of the submittal provided and findings of each panel during the remote interview.

The state reserves the right to offer the use of the On-Call Consultants agreements to other public bodies through the duration of the 2023-2025 biennium, July 1, 2023 through June 30, 2025.
