Item	Questions and Answers		
2.1	Question: Are project types listed in the RFQ including the dollar value and amount of work consistent over an annual basis?		
	Answer: Yes, while the dollar value may change, effort is made to spread this work out over the course of the biennium with consideration given to seasonal and operational influences. All funds must be expended by June 30, 2025.		
2.2	Question: Are your projects contracted through a low-bid process or with a trusted General Contractor? Answer: Yes, low bid is utilized for Design-Bid-Build delivery. State procurement does not allow choosing a General Contractor. Other methods, such as Job Order Contracting through existing Contracts, may be used on select projects.
