# **GC/CM RECERTIFICATION**

- 1. When was the last time the internal project review process was completed and/or revised as this looks like it has not been changed since the first time Spokane Schools became certified?
  - The form was last completed in January 2023 for the Adams Elementary School Replacement project. A copy is attached.
  - Since this use, the form was updated to address potential S/DBE opportunities for use with the upcoming 2024 Bond projects.
  - a. Do you have any completed approval forms you can share for past projects?
    - In addition to Adams noted above, see attached for the combined Albi Stadium and Northwest (Flett) Middle School project.
- 2. What percentage of MWBE participation has been seen in the past projects? There doesn't seem to be mention of it in your application with any results.
  - In the last GC/CM selection process, we requested MWBE data from the firms interviewing in Step 2 and scored their response. All three firms presented extensive outreach processes, direct partnering with MWBE entities, and very positive results in their actual contracting history.
  - SPS has not been tracking past results of MWBE participation. We will commit to compiling such information from our contracting partners on projects over the past few years and work to maintain data gathering efforts going forward.
- 3. Your outreach document is very generic and really does not address how you intend to reach out and increase MWBE participation on the projects. Running an ad and/or talking with GSI is okay but really doesn't show an effort.
  - SPS' is committed to outreach within our community and is reflected within policies created for diversity and inclusion as stated in Board Resolution No. 2020-11 A BOARD RESOLUTION TO ESTABLISH EQUITY POLICIES. These policies are a District wide initiative and in turn is promoted throughout all departments including the Capital Projects Department. We continue to work to apply and refine these concepts to all efforts as an organization.
  - While opportunities are not endless on the east side of the state, the District has made an enhanced effort to find contracting opportunities to support MWBE contractors which includes but is not limited to:
    - Job Order Contracting (JOC) Burton Construction (WBE)
    - ISS (security systems) Camtek (WBE)
    - Outreach to and award of project early site package award made to NNAC (Native American)

- SPS has continued to refine its approach in the qualifications and interview process to address not just contractor's outreach plans but their actual results related to those efforts. We want to know what they have done and the success they have had, so that we can lean on those results, and continue to modify our outreach efforts, not just on our own, but with our contracting partners as well. Some examples of local area outreach in which the District has utilized over the past couple years is through the local and regional AGC to promote our projects as well as through Greater Spokane Incorporated (GSI) which is our local area chamber to continue to expand our reach to as many potential partners as possible. We also address MWBE outreach with our Design Teams.
- In addition to contracting, SPS continues to seek opportunities as it relates to design partners as well as other various professional services companies either through the competitive qualifications process or directly utilizing one of the rosters through a best value process on a project per project basis.
