- In March 2021, Joshua Garcia replaced Carla Santorno as the TPS Superintendent. Prior to becoming the TPS Superintendent, Mr. Garcia served for nine years as the TPS Deputy Superintendent. In ascending from Deputy Superintendent to Superintendent, Mr. Garcia brings continuity of leadership as well as institutional knowledge of the District's capital bond program, capital projects and utilization of alternative project delivery.
- We have added Cheri Estrada, Executive Director of Purchasing to our table showing DB
  experience of TPS staff. Ms. Estrada has been an integral part of our DB procurement process,
  working with Planning and Construction staff and consultants to establish a consistent
  procurement process and develop the procurement documents (RFQ & RFP) that are utilized to
  procure our DB Team partners for our capital projects.
- Our previous certification application identified Julius Pallotta and Kris Anderson as Project
  Managers and staff members of TPS Planning and Construction. Although both Julius and Kris
  remain Project Managers for the District, they are no longer staff members of TPS Planning and
  Construction, have other responsibilities and are therefore have not been listed on our staff
  experience chart for this recertification application. TPS is augmenting our staff with APD
  Consultants to augment our experience and provide PDB Advisory and PM/CM Consultant
  services on our PDB projects. We currently have Consultant Master Agreements with Parametrix,
  OAC and Vanir for these services.

In 2016, the Tacoma School Board and our community partners signed a Tacoma Public Schools Community Inclusion Commitment (see attached) that set practices and goals for new construction and maintenance related construction projects that included, but are not limited to:

- Set a 30% goal for local businesses, headquartered in Pierce County.
- Adopted the Governor's diverse business goals of:
  - 10% minority-owned business enterprises (MBE)
  - o 6% woman-owned business enterprises (WBE)
  - 5% small business enterprises (SBE)
- Requirement for prime contractors to include "voluntary inclusion plans" in all bid packages greater than \$300,000 which will utilize subcontractors.
- Require prime contractors to report and make available to the District and community partners:
  - o Monthly percentages of MBE, WBE and SBE utilized on the project
  - Prevailing wage intents and affidavits
  - Monthly certified payrolls
  - Monthly invoices paid to subcontractors
  - Monthly apprenticeship utilization percentages

The goal of this document and the resulting policies is to support the local community and economy by increasing the participation of local businesses and WA State OMWBE certified MBE, WBE and SBE, investing the tax-payer dollars back into the community, as well as helping to build a strong, diverse, professional community that will be able to tackle the increasing demands in the construction related industries in the Seattle/Tacoma area, the greater Puget Sound region and Washington State.

Specific to our Design-Build projects, our RFQ and RFP documents:

- Include a copy of the 2016 Tacoma Public Schools Community Inclusion Commitment.
- Specifically state the Local, MBE, WBE and SBE goals, as well as the apprenticeship requirements for the project.
- Encourage the prime, DB Contractor to include local and diverse businesses on their team as contractor partners, design consultants, subcontractors and suppliers.
- Include MBE/WBE/SBE & Local scoring criteria that carry significant scoring/weighting and require the prime DB Contractor to provide:

- MBE/WBE/SBE & Local utilization goals and actual utilization achieved on their 3 most recently completed projects.
- A summary of the outreach efforts used to recruit and involve MBE/WBE/SBE & Local businesses on each project.

- A summary of how they have assembled or aligned project work to offer increased opportunities, participation and mentorship for MBE/WBE/SBE businesses.
- A project-specific plan to increase opportunities and encourage MBE/WBE/SBE & Local businesses to participate in the project.
- A project-specific plan to recruit, mentor and involve MBE/WBE/SBE & Local businesses on the project.
- Proposed method to track and report MBE/WBE/SBE & Local business participation and status to the District on a monthly basis.
- Include a copy of and require the prime DB Contractor to complete and attach a copy of the Tacoma Public Schools Design-Build Team Inclusion Plan with their proposal.
- Include draft Contract Documents (Agreement & General Conditions) that state the District's inclusion goals as well as outreach and inclusion-specific language, requirements, processes and procedures.

The Progressive Design-Build project delivery method and the inherent flexibility it offers in the procurement of design consultants, subcontractors and suppliers has allowed Tacoma Public Schools the opportunity to succeed at achieving their diversity and inclusion goals in a manner that has not been afforded in any other delivery method. 
