- Linneth Riley Hall and Vice Chair Twohig reported that CPARB took the PRC's Audit and Accountability subcommittee and turned it into the Project Feedback Process Workgroup. Since neither the PRC nor CPARB have audit or accountability powers, it was decided it would be best to fold the group together with some CPARB members to combine efforts and resources. This workgroup still needs to meet and start identifying the issues to be addressed and worked on.
- Vice Chair Elections.
  - o Talia shared the responsibilities of the Vice Chair position.
  - o Jim Dugan shared his interest in the Vice Chair position.
  - o Linneth nominated Jessica Murphy as a candidate.
  - o Jessica Murphy was elected as the new PRC Vice Chair starting July 1, 2023.
- There was some discussion about possible in-person meeting sites for September 28, 2023.

Pete Maslenikov project executive with Skanska USA. They performed as a general contractor on both the MOB and the recent Patient Access Center (PAC) and rehab renovations. He supports Mason Health's application for approval for recertification. All 3of these past projects were broken out into 2 phases. They really supported the team by creating an atmosphere and a culture of collaboration and trust that allowed us, as the general contractor to partner with the architect, owner, and engineers to find very good solutions to budget challenges like Eric had mentioned with the exterior facade. Janice Zahn, Director of Engineering with the Port of Seattle. She expressed her support for this project and this team. She's been talking with Thais Howard from the very beginning about the concept of this project, and how they might thoughtfully and strategically deliver a successful project. She's delighted that this ILA between Tacoma Public Schools and the Port of Tacoma came to fruition. She believes the project is the right project to have this early engagement all the way to site selection, which is part of best practices of what early engagement really looks like, and they're taking that to heart.
