<u>Mission Statement</u>: To connect the design and construction community with education opportunities, including alternative public works contracting, to enhance industry knowledge, quality and efficiency towards successful outcomes.

Committee Intent Summary: The ECC has been meeting since February. Much conversation in the first couple meeting was about the mission and what the committee's purpose and intent should be; at least to get started. The breadth of thought and focus could expand as we got education connection opportunities identified and posted. As a whole, the committee is working to identify these education opportunities within the design and construction community and connect our partners to those opportunities. The connection would be through a training resource portal that include identified entities that provide a variety of training. The connection/portal is being worked on by Talia. More information for the committee to work through, potentially at our September or October meeting.

Committee Work Summary: The committee's primary focus has been compiling an inventory of available resource entities and their training subject matter; see attached. This will become the basis of connection with some more detail of "subjects" provided. Example: AGC: BIM, LEAN, SAFETY, SUPERVISORY, PROJECT MANAGEMENT etc. As we develop this list, we will be evaluating the resource "subjects" to understand what may be missing and what other recourses we believe needs to be provided and applicable to CPARB's interest.

There has been committee structure conversations taking place over several meetings ensuring a good foundation to work. This includes the following:

- Identifying a chair
- Roles / Responsibilities
- Looking to fill the last two vacancies
- Proxy authority
- Working through our quorum scenario with two vacancies, this has been resolved by the committee. The two vacancies will not count towards a quorum until such time they are filled.

The following are topics of conversation that has been shaping the material to date and/or subject matter we may need to fall back on:

- Provide the resource links but not trying to maintain training calendars of those resources.
- Prime Contractor resources of training; future review/discussion
- Cost of training and small business expense challenge; future review/discussion
- Interaction with other CPARB committee for potential shared info, or to ensure no duplication of efforts. This has started and will continue over the next couple of months.
- How do we notify of the resources compiled to the design/construction community

- Capturing "Best Practices" material as a resource: Design Build, GC/CM as examples
- Owner readiness and information/expectations on PRC applications/presentations; future review/discussion.
- Ensuring resources identified are not all or membership driven to take the class
- Alternative Public Work Contracting Lessons Learned; future review/discussion
