- CPARB Update
 - Lekha Fernandes, Director of OMWBE and member of CPARB, gave a brief overview of CPARB activities that impact the PRC.
 - Many PRC positions have eventually bunched up to the point that multiple positions within the same stakeholder group are coming up for renewal at the same time which doesn't allow for any experienced PRC member of that stakeholder group to mentor the incoming recipient. CPARB's Board Development Committee is brainstorming how to realign the appointments more evenly.
 - The Board Development committee has completed their own Onboarding check list for new members and has also updated the 'Job Descriptions' for CPARB so all members will know

what expected of them.

- The CPARB Small Works Committee helped pass SB 5268 which modified the small works roster requirements into one statewide system and creates a small business certification program. Implementation is set to be July of 2024.
- CPARB also reconstituted the BE/DBI Committee to continue the work started last year with the BE/DBI report to the legislature of reducing barriers for within the construction industry.
- CPARB appreciated the PRC's initiative to start a workgroup to address conflicts and issues that come up after owners have come to the PRC. They created the Project Feedback Process Workgroup. This workgroup consists to the initial PRC members who volunteered to be on the Accountability subcommittee, and CPARB members. The goal is to research and identify a process for addressing these issues within the parameters of state government or making recommendations to CPARB on possible statute modifications to maintain the integrity of the PRC and CPARB.
- Vice Chair Election
 - \circ $\,$ No letters of interest were submitted for the PRC Vice Chair position.
 - o Jim Dugan expressed interest in the Vice Chair position.
 - o Linneth Riley Hall nominated Jessica Murphy as a candidate for the position.

Chaired by Jeff Jurgensen\Kyle Twohig – Full Committee of 26 members with 7 members absent.

- Vice Chair Twohig shared an overview of the flow of PRC meetings and welcomed new members Gina Hortillosa, Ron Paananen, Catina Patton, Lance Thomas, and Anthony Udeagbala who shared a little about themselves.
- Committee members discussed the pros and cons of the hybrid meeting in May.
 - The only real challenge was a review where the panel chair was virtual, but the applicant was in-person. For future hybrid meetings leadership will strive to match up in-person applicants with in-person chairs.
 - Members would like to continue to have 2 hybrid meetings a year: one on either side of the state. Talia has not identified a location in the Seattle area yet for the September PRC meeting.
- Mentor\Mentee Program Update Future Onboarding
 - There are 5 new incoming members that need mentors. Jeff Jurgensen, Eza Agoes, Tim Buckley, Jim Dugan, Tom Golden, Jeannie Natta, and Young Song offered be mentors.
 - Vice Chair Twohig will work with incoming Vice Chair Murphy to make the mentorship pairings.
 - Young Song and Eza Agoes shared their positive experiences with the new Mentorship Program.
 - Vice Chair Twohig recommended shortening the check list deadline to 6 months.
- Application Review & Online Examples Review & Updates
 - Several updates were discussed for the current application and score sheet forms.
 - Additional language was suggested to be added to the GC/CM project application:
 - Add Yes\No question to question 1 on whether or not this application includes ASSP. A sub note that supplement B will need to be submitted in the future if not applying for ASSP at this time.
 - Add Alternative Subcontractor Selection to the budget section.
 - Add reminder in question 3 to use supplement A if applying for ASSP.
 - Additional language was added to the DB project and certification applications adding a request to include past performance inclusion goals and actual costs.
 - GC/CM project score sheet will be updated to include scoring for ASSP.
 - ASSP Supplements A & B need to be reviewed to make sure the project schedule is reviewed.
 - All forms will be updated for consistency and presented for final approval in July.
- Alternative Subcontractor Selection Discussion
 - Kurt Boyd was on the CPARB EC/CM-MC/CM Committee in 2016 that created the legislative report posted on the CPARB Background and Reference page.

 - All scoresheets are due the same day as the meeting, and they must be signed. New members can run them by their mentor first if preferred. Please let Talia know if this is the case.
 - When sending in Questions to the applicants, please remember they are to be questions only and not advice. When giving advice the PRC members must then recuse themselves from that review to avoid a conflict of interest.
 - Each panel chair is the facilitator of that review and must try to keep to the panel time frames for consistency.
 - During the deliberation period, members are encouraged to share their concerns and impressions about the project, but not to state their voting preferences. Additionally, the deliberation period is just between the panelists and not a time to address the applicant.
 - The 2-minute clarification period is still a new addition to the schedule, but this time is <u>only</u> for clarification by the applicant and panel chairs must remain firm that no new information is to be added.
- Mentoring\Onboarding Update
 - The mentorship program has been very helpful for the new members.
 - New members are encouraged to discuss the pre-questions with their mentors prior to turning them in to the panel chairs.
- Updated Forms Edits/Approval
 - All application forms were reviewed, and new language added to include past performance and utilization goals.
