

Statewide indemnity payouts for FY 2018-2025






FY 2025 statewide indemnity payout distribution (\$499,106,030)

All other state agency indemnity payouts FY 2018-2025




72% of event payouts are less than \$100,000 each and make up 1% of total dollars paid out for indemnities.

Large payouts result from a small number of events (Severity = High / Frequency = Low) (Excludes UW and Excess Insurance Refunds)



Statewide tort claim filing for FY 2018-2025






FY 2025 tort claim filing by investigative office assigned




FY 2018-2025 tort claim filing by investigative office assigned



Distribution of DOC claims filed FY 2018-2025




DOC indemnity payouts FY 2018-2025




Distribution of DOT claims filed FY 2018-2025



Distribution of DCYF claims filed FY 2018-2025




DCYF indemnity payouts FY 2018-2025




Employment tort claims filed FY 2018-2025




Employment tort claims paid FY 2018-2025
