




Local Government Public Works Contracting Study—Update

May 13, 2021

Purpose of Committee

- Problem statement: The legislature receives multiple requests each session to adjust public works contracting thresholds and processes.
- SB 5418
- Committee Charge: Review public works contracting processes for local governments, including the small works roster and limited public works processes, and create recommendations for efficiency to be presented to the CPARB Board.
- Review will:
 - Identify most common contracting procedures
 - Identify current public works contracting thresholds
 - Analyze applying an inflation-based indicator and other potential threshold adjustments
 - Recommend ways to increase uniformity and efficiency for local government public works contracting
 - Identify rates of participation for small and minority-andwomen owned businesses and barriers to improving the participation rate

- Two additional committee meetings

 - Focused on SWR Threshold and Resources for Public Works recommendations

- Implement a review at 5-year intervals for SWR threshold revisions Committee in consensus
- Implement the use of an inflation factor to apply the revisions Committee in consensus

Board motion to recommend?

 Apply SWR revisions by means of a statewide inflation factor Chosen by the majority of the committee, 8-2

Board motion to recommend?

• Apply inflation revisions automatically at each five-year interval Chosen by the majority of the committee, 5-4-1



Professional Assistance Recommendation (#11)

Board motion to recommend?

11. Provide professional assistance for Public Works contracting guidance and marketing and outreach to contractors

Chosen by the majority of the committee, 9-1

- Includes coordination of committee's unanimous recommendations #6, 7, and 10 (if passed) -next slide- and a coordinated effort between MRSC, PTAC and OMWBE in providing assistance
- Additional committee and chair discussion after the vote determined that a specific funding number was not prudent to be included in the recommendation and that the recommendation should be more broad, distinctly covering Public Works vs only Local Government







SWR Threshold increase - Committee Recommendations

- Original Recommendation: Tie Small Works Roster (SWR) threshold increases to state-wide inflation factor based on CCI
- Alternative Recommendation #1: Apply an automatic statewide inflationary increase based on the CCI to the Small Works Roster at five-year intervals
- Alternative Recommendation #2: Review potential Small Works
 Roster threshold increase at five-year intervals guided by a state-wide
 CCI inflation factor
- Alternative Recommendation #3: Review potential Small Works
 Roster threshold increase at five-year intervals guided by a regional
 CCI inflation factor (regional index to be established)




